### **Purpose of the Course**

In this course we will examine major theories of organizations asking how well they help us explain the characteristics and dynamics of social and political organizations like nonprofits, civic associations, interest groups, congregations, and social movement organizations. Implicitly most organizational sociologists examine market-based organizations, but formal organizations constitute many other areas of social life from local neighborhood associations and congregation to transnational advocacy groups and social movement organizations. Because this is a kind of hybrid course, we will draw from multiple subfields and disciplines beyond organizational sociology including political science, nonprofit studies, social movements, political sociology, and sociology of religion. This course will also introduce students to major strategies for studying organizations including historical, fieldwork and case studies, surveys, event history, and network analysis.

#### Class Format

This course will be organized as a seminar – meaning that we will use our meetings to collaboratively evaluate, apply, and critique work on political and social organizations. Each Tuesday I will post or email observations about the reading and its place in the broader field and pose several discussion questions for the following meeting. I will also meet with two students who will be responsible for preparing a brief response to those questions to launch our weekly meetings the following Monday. Your response should focus attention on key analytic issues and help set the stage for broader discussion and debate. You should not summarize the readings. Everyone will have read the readings beforehand, and we can address any questions about what the readings mean through our discussion of them.

In addition to engaging discussion questions at two meetings, the other major requirement is a research proposal. Your proposed research must be conversant with major themes and scholarship addressed in this course. Your proposal will be developed through two initial drafts and a final version. If appropriate, this paper should include the findings of preliminary research. The goal for this assignment is a proposal suitable for a master's paper, grant/fellowship application, or dissertation. You may propose an alternative writing format if it would be more appropriate for you at this stage of your graduate career or program – such as a literature review. I will circulate a detailed handout on the paper assignment at our September 8<sup>th</sup> meeting.

Course grades will be based on class participation throughout the semester (25%), discussion questions/presentation (25%), and the research proposal (50%).

## Readings

The majority of our readings for this course come from journals or sections of books. These materials will be available through the course webpage. Our readings combine "classics" in the field and recent work at the forefront of current scholarship. Given the breadth of the course, our readings are selective and should be seen as a starting point – especially if you plan to do further research in this area.
